The arts & crafts fair this year is on **Saturday and Sunday, October 1-2 and 8-9**, and thousands of visitors come to Fulton County over these two weekends. Enclosed are the registration forms for the 2022 Scenic Drive in Canton and the Registration Contract for the Spoon River Valley Scenic Drive Association (SRVSDA).

The setting in downtown Canton is an intimate venue where your merchandise can truly be appreciated. **We are always looking for vendors to sell handmade items, crafts, genuine collectibles, antiques, primitives, plants, flowers, candles, jewelry, and other similar items. Items not allowed for sale at our Canton Jones Park location are any items promoting any form of politics, political parties, or specific political candidates, any items that are racially suggestive or promote racism, and absolutely NO sale of firearms and weapons. A very limited number of representatives of reputable retail lines have been accepted with prior approval. The City of Canton owns Jones Park and reserves the right to not allow certain items and activities to take place on the property. The use of any type of illegal drug and alcohol is prohibited on the property as well.**

During both weekends of Scenic Drive, we will have a Hospitality Table for vendors each day of the, with a free breakfast items, coffee, and bottled water. We also have scheduled entertainment for both weekends, drawing more visitors to Canton's site.

Vendors wishing to set up at the Canton site in Jones Park must complete the enclosed Canton Site Registration Form. The Canton Site Registration fees are set on a "Per-Day" rate, and vary depending upon whether electricity is required. The Canton Site registration fees help to defray the cost of utilities, insurance and advertising the Canton event. **IMPORTANT: All vendors participating in the 2022 Spoon River Valley Scenic Drive must also complete the Registration Contract for the Spoon River Valley Scenic Drive Association (SRVSDA) and return it with their separate \$50.00 registration fee by September 1, 2022. After September 1, the SRVSDA registration fee increases to \$75. Registering with the Canton Site does NOT automatically register you as a vendor with the Spoon River Scenic Drive Association. You must complete both forms, and send them separately with your separate payments to the addresses indicated on the applications.**

Also, please note that if your registration is in by June 1, 2022, your information will be included in the Canton portion of the 2022 Spoon River Drive Guidebook!

Absolutely NO sale of firearms, weapons, items promoting any form of politics, political parties, or specific political candidates, any items that are racially suggestive or promote racism or alcohol will be allowed. Obscene or illegal items are prohibited. The City of Canton and the Canton Site Representative reserves the right to determine what items will be allowed for sale at the site during the Spoon Valley River Scenic Drive.

The Canton Site Representative or the City of Canton will not be responsible for injury to or the safety of any exhibitor’s property, including theft, fire, accident, weather or other occurrence, nor shall they be held liable to the exhibitor or their employee or agent for loss or injury from such cause. Exhibitors shall assume full responsibility, therefore, and hold the Site Manager, the City of Canton, Canton Main Street, the Spoon River Partnership for Economic Development, their members, officers, or directors harmless from any and all losses or damages arising participation in the Spoon River Valley Scenic Drive at the Canton site.
