Camping fees are as follows:

Campers must present a valid driver's license or government issued photo I.D. to receive the Resident rate. A Resident is defined as all persons whose principal residence is within the corporate limits of the city of Canton, or who hold a Canton Lake lot lease, is current on lease payments and in full compliance with their lease provisions. The address as set forth on the applicant's driver's license or government issued photo I.D. shall be prima facie proof of residence.

There will be a \$25.00 charge for any returned checks, and camper will be required to pay in cash thereafter.

Camping and Fishing Rules

- Camping shall be in designated areas only.
- Trailers must be a minimum of 25 feet apart.
- Outside refrigerators are not allowed.
- Pets must be confined on a lease at all times. Dog houses are not permitted.
- Picnic areas are reserved for campers only. Public picnics are not permitted.
- Camp sites are limited to one picnic table per site.
- Fireworks are NOT allowed anywhere in the campground. Violators will be asked to vacate the campground immediately.
- Fishing shall be pole and line only. Trot lines are not permitted.
- All fish heads, entrails, and other refuse and garbage shall be rolled in paper, placed in double plastic bags, sealed and then deposited in a designated trash container.

Boating Rules

- All boats shall be launched and retrieved at the boat dock or boat slip areas only.
- Speed limit is 30 mph, and watercraft will operate around the lake in a counterclockwise direction.
- Children should be supervised on the boat dock.
- Rubber rafts shall not be launched or retrieved at the campground or the old beach area.
- All persons shall stay out of boats tied up at the campground or boat slip areas.
- All boats or watercraft operated between sunset and sunrise shall be equipped with lights that can be clearly observed from any quarter by an approaching boat and that meet all provisions of Illinois State Statutes. A "no wake" period is in effect between sunset and sunrise for all boats and watercraft.

Swimming

• Absolutely NO SWIMMING is allowed at the old beach. This area is not approved for public swimming.

Storm Shelters

• In case of severe weather, storm shelters are located at the shower house or at the Water Treatment Plant on Lakeshore Drive near Co. Hwy. 27.

If any such person fails or refuses to leave the campground, he shall be subject to a fine of not less than twenty-five dollars (\$25.00) nor more than five hundred dollars (\$500.00) for each such failure or refusal.
