## General Information

**Date:** Saturdays  
June thru September

**Time:** 7:30 a.m. – 11:30 a.m.

(Note: No sales will be allowed before the start time of 7:30 a.m.)

**Location:** Jones Park, Downtown Canton

**Booth Location:** Booth spaces will be assigned on a first-come, first-served basis. Awnings or canopies are encouraged for sun and rain protection.

### Seasonal Booth Rate:

Single (10' x 10') \$75

Weekly Rate (10' x 10') \$10

**Facilities:** Vendors must provide their own tents, chairs and means of display. Electricity is available for vendors that require refrigeration.

**Maintenance:** Vendors are responsible for clean-up of their own area during and after each event. All tents must be weighted.

**Signage:** We encourage vendors to display some kind of signage to advertise their organization, business, or name and location.

**Parking:** Vendors will be required to park their unused vehicles in public parking lots one block off of the square during hours of operation. There is no charge to park in these City-owned lots.

## General Guidelines

- **No wholesale vendors re-selling food items will be allowed. This is a “made and/or grown by seller only” market. Canton Main Street reserves the right to verify the sources of a vendor’s products.**
- Vendors must complete, sign and date the application and release before being allowed to set up for the Market.
- Vendors may offer for sale items including, but not limited to, fruits, vegetables, plants, flowers, edible grains, nuts, berries, maple sugars, syrup, eggs, dairy products, meat, poultry, or fish.
- All canned or jarred food, eggs, dairy products, meat, poultry and fish offered for sale shall conform to the Illinois Retail Food Store Sanitation Code. Vendors selling these items must have met all regulations and received proper certification and permitting from the Fulton County Health Department. Call the FCHD at 309.647.1134.
- Pre-packaged items, such as baked goods offered for sale must be registered with the Fulton County Health Department. There is no fee to register these items.
- No exclusive rights can be granted for the sale of any specific item.
- No alcohol (including beer and wine) may be served for sale.
- Rain or inclement weather will not be considered grounds for refunding any fees. Vendors should make every effort to determine weather conditions before choosing to set up.
- Vendors may sell food products directly to the public without paying State, City, or County tax. Taxes owed from the sale of non-edible items are the sole responsibility of the vendor.
