The Canton Area Chamber of Commerce is a non-profit organization funded by memberships and event fundraisers. In fact, 55% of our income depends on memberships each year. The remaining 45% relies on fundraising efforts. Well, just like most not-for-profits, the Canton Chamber is feeling the effects of the COVID 19 pandemic. Because we are a registered 501(C)6, we were not eligible for any federal or state funding to sustain our operations at 100%. In May, we had to let our Assistant Director go.

The Canton Chamber started 2020 with a bang. We were able to have the Annual Chamber Dinner in February and honor well-deserved recipients. But then the pandemic hit. We had to cancel our annual golf outing, scheduled for May 15th, which is the Chamber's largest fundraiser of the year. We canceled rather than re-scheduled it because our committee did not want to ask local businesses for sponsorships while they were trying to get back on their feet. Our focus was (and still is) on helping them – not asking them to help us at this time.

Then, due to the Retore Illinois guidelines, we had no choice but to cancel the annual Canton Cruise-In as we know it. This event is also a fundraiser for the Canton Area Chamber of Commerce but we re-imagined it into the Canton Cruise THRU Parade. We wanted to create a fun day for those who participate in this newly created event, being planned on July 11th at 10:00 am, but we also wanted to create a safe event for the citizens of Canton. While we have all these visitors in town, we decided to create reasons for them to stimulate our local economy by giving them information on where to grab lunch, go shopping or take a drive in Fulton county.

MESSAGE FROM THE SUPERINTENDENT of CANTON SCHOOLS

What Will School Look Like in the Fall by Rolf Sivertsen

Recently the State Superintendent of Schools, Dr. Carmen Ayala, released administrative guidelines for school districts conducting summer education programs. The document outlined recommendations to provide safe in-person instruction while reducing the risk to COVID 19 infection. The guidelines were adopted through the input from a variety of sources. For example, the State Superintendent assembled a team of stakeholders that included teachers, administrators, school nurses, social workers, students, and ISBE staff. The team shared their thoughts and best practices to develop and hone a final document of guidelines that that will provide a safe and healthy environment for all 852 school districts.

Using a similar process, we anticipate the Illinois State Board of Education (ISBE) to release a transition plan that will advise school districts on the restart of schools for the 2020-21 school year sometime during the third week of June (not known at the time of this writing). We expect the transition plan will provide remote learning recommendations soon thereafter. The nature of the transition plan will be predicated on COVID Data in the EMS Regions 3 & 6 Central Region. It is my opinion that Canton Schools will be under a Restore Illinois Phase 4 order. The Phase 4 model, Revitalization, is defined as the following:

The rate of infection among those surveillance tested and the number of patients admitted to the hospital continues to decline. That means that schools will be restricted to:

- Gatherings of 50 people or fewer are allowed, restaurants and bars reopen, travel resumes, child care and schools reopen under guidance from the Illinois Department of Public Health.
- Face coverings and social distancing are the norm.

These guidelines will more than likely require our district to transition to a blended model that will restrict student attendance to 50% on any given day. In response to this anticipated guidance our school district is creating a team of teachers, administrators, and other personnel to create a schedule that will be conducive to a Phase 4 implementation. As this process progresses I will keep all of you informed.
