## COVID-19 Business Resources

The coronavirus pandemic has effected and will continue to effect small businesses in many ways. From loss of revenue, to figuring out how to remotely work from home, things are changing quickly and we are all being forced to adapt. There are many resources out there to assist businesses through this crisis.

The Illinois Department of Commerce & Economic Opportunity has launched emergency assistance programs for Illinois small businesses.

### **Illinois Small Business Emergency Loan Fund**

DCEO and the Illinois Department of Financial and Professional Regulation (IDFPR) are establishing the Illinois Small Business Emergency Loan Fund to offer small businesses low interest loans of up to \$50,000.

Businesses located outside of the City of Chicago with fewer than 50 workers and less than \$3 million in revenue in 2019 will be eligible to apply. Successful applicants will owe nothing for six months and will then begin making fixed payments at a below market interest rate for the remainder of a five-year loan term.

### **Downstate Small Business Stabilization Program**

To support small businesses in downstate and rural counties across Illinois, DCEO is repurposing \$20 million in CDBG funds to stand up the Downstate Small Business Stabilization Program. This Fund will offer small businesses of up to 50 employees the opportunity to partner with their local governments to obtain grants of up to \$25,000 in working capital. These grants will be offered on a rolling basis.

It's a new marketplace launching for shoppers to purchase products sitting in closed up shops. Businesses can create listings instantly right from a smartphone or computer, get a link to share with audiences without having to build an online store, and push listings to thousands of shoppers across the country looking to support small businesses. As of right now the Canton Art on Main Fine Arts Festival has not been cancelled. But with that said, the Art on Main Committee will be meeting via video and phone conferencing on Monday, April 20th to discuss the possibility of cancelling this year's show. The committee either on that day will make a decision to cancel the show, or will pick a last possible day before the show to make the decision to cancel. Though June 6 & 7 seems like a little way away, and no one wants this COVID-19 pandemic to last longer than April 30th, there is a chance that it could. Once our shelter-in-place is lifted, there could be the chance that certain restrictions will be in place, and could prevent the committee and Canton Main Street from holding the show.



As of right now the Canton Main Street Farmer's Market will open as usual, but may open at a later date than June 6th. **THIS HAS NOT BEEN DETERMINED YET, THOUGH.** Farmer's Markets are considered essential and access to fresh produce is an essential part of our lives. If the market opens as scheduled and COVID-19 restrictions are in place, the market will be following certain procedures and operational guidelines to reduce the risk of spreading COVID-19.
