


Farmer's Market Started This Month!!

Spotlight of the Month, Bar-Mac Farms of Canton, IL Even though they are not a business specifically located in downtown or on main street, Bar-Mac Farms has been a member and supporter of Canton Main Street for many years!

Bar-Mac Farms is owned and operated by Leonard and Wendy Bernard. The farm is strictly a grain one, with corn and soybeans. The farm has been in the family and continuously operated since 1888. The name Bar-Mac is a mix of Bernard and Wendy's maiden name, MacBroom. Leonard and Wendy run the farm with the help of his brother and sister, and grandson who will be attending Spoon River College.



Leonard grew-up on the farm with his father L.D., and his mother Virgina, along with his brother and sister. He graduated from Canton High School in 1971. Barnard stated he has always had a love of cars, so after graduation he headed to Nashville, TN to a trade school to study auto diesel mechanics.

After he finished in Nashville, he came back to Canton to work on his parent's farm. Bernard planted his first crop in 1975. He worked several different jobs over the next several years: Locked Auto where he was able to work on cars, Consolidated Coal in Norris, and the City of Canton.

The Barnards are very community oriented. They have been involved with many different organizations in the community. Leonard now sits as President of Canton's School Board. He states that it is important to support Canton's downtown, as small businesses are the backbone of any small community.

Last month I talked about the effect of the COVID-19 pandemic and its effect on not only on the world, but on Canton, and the overwhelming hardship it has placed on our community, and specifically local businesses. Fulton County has been blessed to have very few cases and no deaths, but the stay-at-home orders mandating that all nonessential establishments close to prevent the spread of the virus hit our downtown business hard. I said we needed to roll up our sleeves and get to work.

I am very proud to tell you that we have already started. In collaboration with the Spoon River Partnership for Economic Development, Canton Main Street redirected \$3,000 set aside for micro-grants and pooled resources with the SRPED to help provide nine \$1,000 grants to local business. Three of the awardees are located in Fulton County, while the remainder are here in Canton. I can tell you after being a part of the team that read and scored the applications, the need was heartbreaking. Canton Main Street should be proud to have been a part of that effort. My only wish is that mores funds were available to do more to help these hometown operations.

So, we will continue to look for ways to help assist our downtown to recover and thrive. That is what Canton Main Street does, and a long-term focus will be needed. At some point, the virus will dwindle, vaccines will become available, and we will find a new normal. But if we want these wonderful shops and businesses to survive, we each have a responsibility to keep our sleeves rolled up and dig in. We are now in Phase Three of Illinois re-opening, which means most businesses have opened their doors again, even if it is with limitations. We will be surveying the downtown to find out what other needs these businesses have that we may be able to address as they open.

In the meantime, wear your mask, take your hand sanitizer and *patronize* them. Give them a hand up by walking through their doors and shopping, dining or using their services. They need us. We can help.

A message from Mayor Kent A. McDowell Guidelines re: Retail and Restaurant Openings May 29, 2020

The Governor has issued a directive enacting Phase 3 of his reopening plan which goes into effect on May 29, 2020. This directive allows restaurants/bars (only in outdoor areas), retail businesses, fitness facilities, service salons, golf courses, and State parks to open with limitations. Precautions are to be taken such as social distancing, face masks, sanitation, signage, etc. His directive also encourages each municipality to help restaurants/bars expand their outdoor seating areas. Be aware that our region could slip back into Phase 2 if the health matrixes indicate a rebound in virus cases, etc. Also understand that the conditions outlined below are only temporary and things will change again when we enter the Governor's Phase 4...
