CANTON GUIDELINES & CONDITIONS

The Canton location registration fees are a set \$25 per-day/per 10x10 space. Fees help to defray the cost of insurance, advertising the Canton location and breakfast food/coffee for vendors each morning.

Vendors should be ready to open their booths no later than 9:00 a.m. each day they are registered. Tear-down should not occur before 4:30 p.m. on each day.

Items not allowed for sale at our Canton Jones Park location are any items promoting any form of politics, political parties, or specific political candidates, any items that are racially suggestive or promote racism, and absolutely NO sale of firearms and weapons.

Jones Park is owned by the City of Canton, which reserves the right to prohibit certain items and activities. The use of illegal drugs and alcohol is strictly prohibited.

SRVSD ASSOCIATION

All vendors participating in the Spoon River Valley Scenic Drive must complete the Registration Contract for the Spoon River Valley Scenic Drive Association (SRVSDA) and pay the associated \$50.00 registration fee by September 1, 2025. You will receive the SRVSDA Registration Form separately along with this form. Please note: Submitting only one form does not complete your registration.

Registrations completed by July 15, 2025 will ensure your information is included in the Canton portion of the Spoon River Drive Guidebook.

IMPORTANT

There are TWO forms you must fill out in order to participate in the Spoon River Valley Scenic Drive and each form has it's own set of fees. You may submit both forms along with a single check covering the site daily fee and the Association fee to Canton Main Street.

1. The Canton Site Registration form (\$25/day as listed above) ____
2. The SRVSD Association Contract (\$50 registration fee) ____

For 2025, we will accept both registration forms and full payment for both fees together, submitted in one package, through September 1, 2025.

In previous years, forms and payments had to be sent separately. This year, we'll process everything together—making it easier for you. After the deadline, however, separate submissions will once again be required.

The Canton Site Representative, City of Canton, Canton Main Street, Spoon River Partnership for Economic Development, and their affiliates are not responsible for any loss, damage, or injury to exhibitors or their property due to theft, fire, weather, accidents, or other causes. Exhibitors assume all risk and agree to hold all parties harmless from any claims arising from participation at the Canton site of the Spoon River Valley Scenic Drive.
